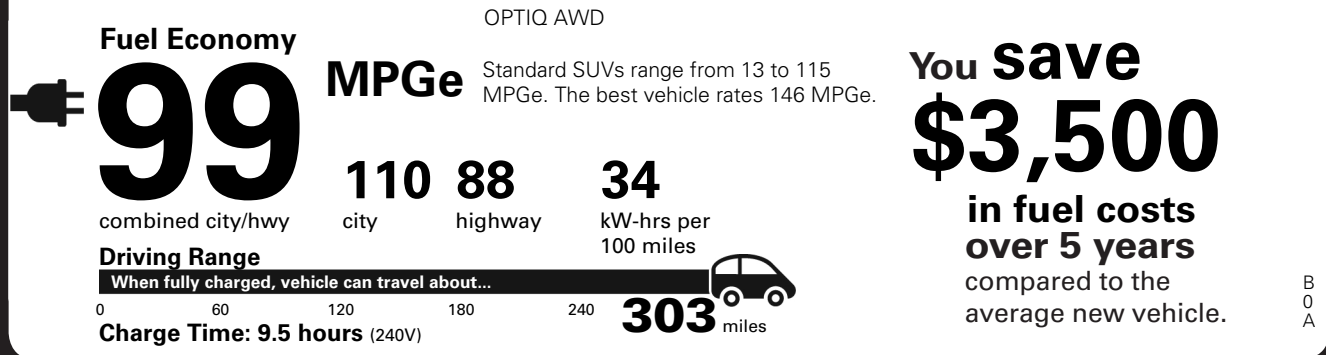

Electric Vehicle



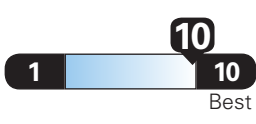
